RESOLUTION #21-2010

INTRODUCED BY: THOMAS SCHULTZ

INTENT: REQUEST THE WISCONSIN DNR AND OTHER PARTNERS TO IMPLEMENT MEANINGFUL POPULATION CONTROLS IN THE NEXT WISCONSIN WOLF PLAN

WHEREAS, Thomas Schultz introduces this Resolution in his individual capacity as a member of the Langlade County Board of Supervisors; and

WHEREAS, the Wisconsin Department of Natural Resources (DNR) established a wolf population goal of 350 animals in 1999; and

WHEREAS, since that time, the Wisconsin DNR has not provided for meaningful wolf population control in any of its management efforts; and

WHEREAS, Langlade County residents have experienced depredation and threatening incidents involving wolves; and

WHEREAS, higher wolf populations have resulted in lower deer harvests and threatened livestock.

NOW THEREFORE, BE IT RESOLVED, that the Langlade County Board of Supervisors hereby requests the Wisconsin DNR to keep the wolf population goal for the State of Wisconsin at 350 or less in the next Wisconsin Wolf Plan.

BE IT FURTHER RESOLVED, that the Langlade County Board of Supervisors requests the Wisconsin DNR and other partners to implement meaningful population controls in the next Wisconsin Wolf Plan to bring the wolf population down to the management goal.

BE IT FURTHER RESOLVED, that the Langlade County Clerk be directed to forward a copy of this resolution to the Secretary of the Wisconsin DNR, Matthew Frank, Secretary of the Wisconsin DATCP, Rod Nilsistuen, Governor Jim Doyle and Langlade County's representatives in the Wisconsin State Senate and Assembly.
