WOLF CONTROL ADVISORY RESOLUTION

WHEREAS, the Wisconsin Wildlife Federation and Wisconsin Farm Bureau have officially approved a wolf goal of 350 or less and the WI DNR plans to review their previous wolf management plan, adopted in 1999 and revised in 2007, and

WHEREAS, the Wisconsin Conservation Congress public hearings in 2011 supported the wolf population of 350 or less and over 20 county boards in northern and west central Wisconsin have passed resolutions recommending same, and

WHEREAS, Wisconsin residents have experienced threatening incidents involving wolves to their animals and to human safety and the high predator population has resulted in reduction of the deer population where wolves are plentiful reducing hunting opportunities.

THEREFORE BE IT RESOLVED that the Marquette County Board advises that the next revision of the Wisconsin Wolf Plan set a population goal of 350 and asks that the WI DNR not relocate wolves creating problems to other counties in Wisconsin.
