Ladies and Gentlemen:

RESOLUTION OPPOSING LEGISLATION SIGNIFICANTLY ALTERING THE BALANCE OF POWER BETWEEN COUNTY EXECUTIVES AND BOARDS

WHEREAS, recent Bills have been introduced in the Wisconsin Senate and Assembly that, if enacted, would significantly alter the balance of power between County Executives and County Boards in Wisconsin; and

WHEREAS, such Bills include, but are not limited to, 2017 SB 777, 2017 AB 923, LRB5135/1 and LRB5135/2; and

WHEREAS, it is desired that, prior to *any* such proposed legislation being voted upon and becoming law, the 72 Wisconsin Counties, through their boards, officers and corporation counsels, <u>and</u> the Wisconsin Counties Association, both be afforded ample time and opportunity to provide input on said legislation.

NOW, THEREFORE, BE IT RESOLVED that the Brown County Board of Supervisors hereby opposes *any* legislation that would significantly alter the balance of power between County Executives and County Boards in Wisconsin, and will continue to do so unless and until such time as the 72 Wisconsin Counties, through their boards, officers and corporation counsels, <u>and</u> the Wisconsin Counties Association, are both afforded ample time and opportunity to provide input on said legislation.

BE IT FURTHER RESOLVED that the County Clerk shall forward a copy of this Resolution to the Wisconsin Governor, Wisconsin Counties Association, State Representatives and State Senators representing the Brown County area.

Fiscal Note: This resolution does not require an appropriation from the General Fund. The cost to carry out the resolution is \$5.98 and can be covered with the department's current budget.
