4 **RESOLUTION NO. 2021-92**

6 **WHEREAS**, Sawyer County (the "County") is currently performing its obligations of
7 redistricting pursuant to Wis. Stat. § 59.10(3);
8

9 **WHEREAS**, on August 19, 2021, the County Board of Supervisors ("County Board")
10 initially determined that the County shall maintain its current number of supervisory districts
11 of 15 for purposes of completing the preliminary work necessary for the County's tentative
12 redistricting plan;
13

14 **WHEREAS**, the County then prepared three (3) draft versions of tentative redistricting
15 plans, and a copy of each tentative redistricting plan is set forth herein as Exhibit A, Exhibit B
16 and Exhibit C (collectively, the "Plans");
17

18 **WHEREAS**, pursuant to Wis. Stat. § 59.10(3)(b)1., the County Board must adopt a
19 tentative redistricting plan by selecting one of the Plans attached hereto;
20

21 **WHEREAS**, pursuant to Wis. Stat. § 59.10(3)(b)1., a public hearing was held on
22 September 16, 2021 for public input on the Plans;
23

24 **WHEREAS**, the contents of this Resolution and the Plans were discussed at the County
25 Administration Committee meeting on September 9, 2021, and the County Administration
26 Committee voted to recommend to the County Board that it adopt this Resolution and Tentative
27 Redistricting Plan No. 3v2, as set forth in Exhibit D at its meeting on September 16,
28 2021;

30 **WHEREAS**, the County Board then discussed this Resolution and the Plans at its
31 meeting on September 16, 2021.
32

33 **NOW, THEREFORE, BE IT RESOLVED**; the Sawyer County Board of
34 Supervisors determines, adopts and directs the following:
35

- 36 1. Recitals. The Recitals set forth above are true and accurate, and are therefore
37 incorporated into the Resolution and shall be used not just for reference.
38
- 39 2. Adoption of Tentative Redistricting Plan. The County Board
40 hereby selects Tentative Redistricting Plan No. 3v2, as set forth
41 in Exhibit D, as the tentative redistricting plan pursuant to
42 Wis. Stat. § 59.10(3)(b)1.
43
- 44 3. Additional Steps. The tentative redistricting plan selected herein
45 shall be sent to each municipal governing body in the County for
46 consideration and potential modification. Thereafter, the County

47 Board shall hold another public hearing and thereafter adopt a
48 final supervisory district plan. Nothing in this Resolution shall be
49 construed as action on or adoption of the final supervisory district
50 plan.

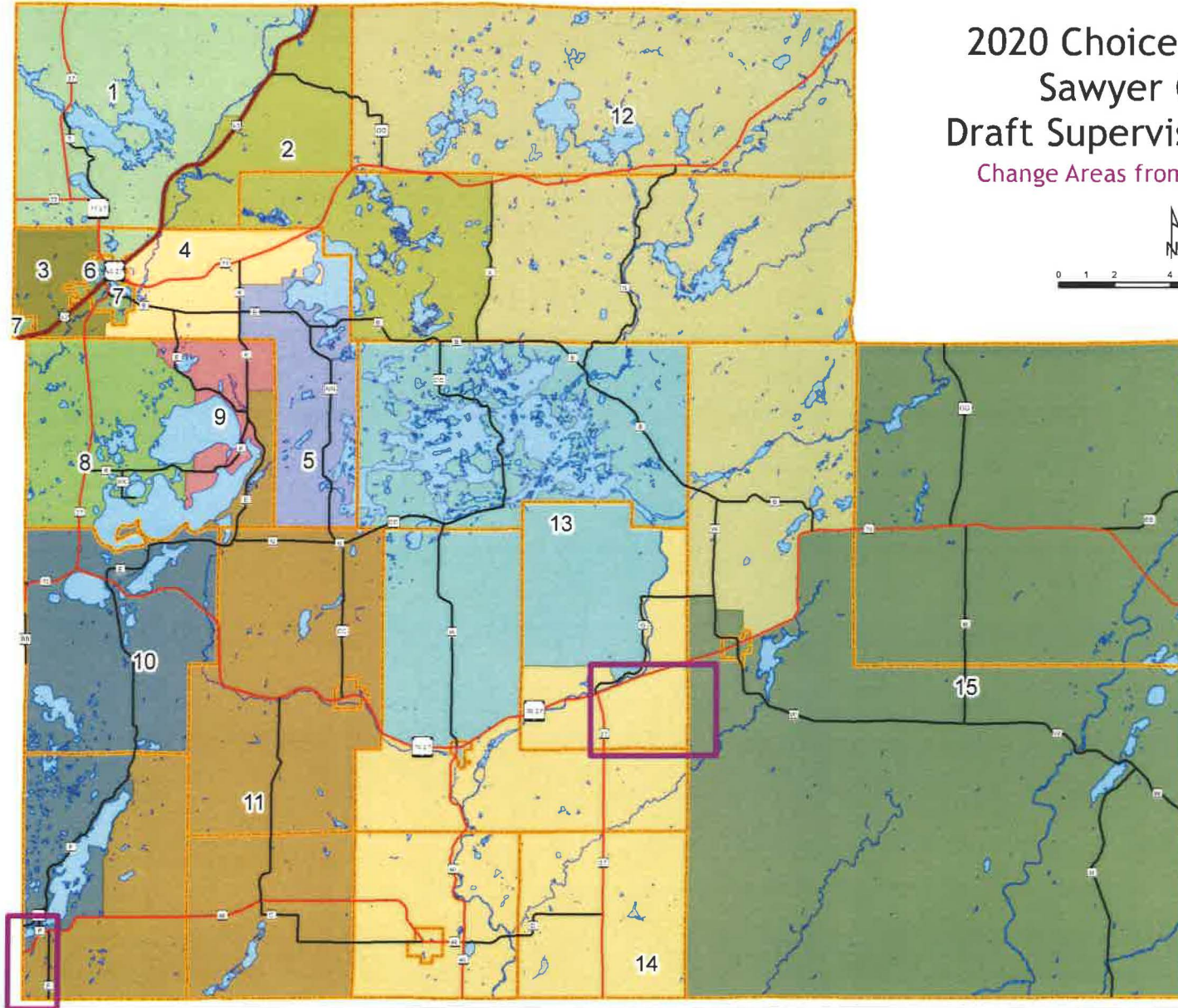
