2 RESTRUCTURING OF COMMUNITY SUPPORT PROGRAMS (CSP)
3 FOR MENTAL HEALTH AND SUBSTANCE ABUSE
4

5 WHEREAS, Wisconsin counties are tasked with primary responsibility to address the needs of persons
6 with mental illness and substance use disorders; and,

7 WHEREAS, this includes providing direct care or contracting for care with providers to deliver mental
8 health services and substance abuse services that meet the needs of individual constituents; and,

9 WHEREAS, Counties are required to provide a number of human service programs for persons in crisis –
10 regardless of their County of residence- including 24-hour telephone and in-person service, mobile crisis
11 for in-person response, walk-in services, and short-term voluntary and involuntary hospital care; and,

12 WHEREAS, the costs of operating these programs for Counties has increased significantly but State aids
13 supporting them have not kept up; and,

14 WHEREAS, Counties are experiencing a growing tax levy burden to support these programs and provide
15 matching dollars for State and Federal program funds; and,

16 WHEREAS, the burden of these increasing costs has a detrimental effect on County budgets already
17 limited by other mandates and levy caps; and,

18 WHEREAS, counties use existing mental health programs including;

19 **Community Recovery Services (CRS)** – helps teens or adults with mental illness through
20 outpatient services for their unique recovery needs.

21 **Comprehensive Community Services (CCS)** – all ages support by addressing individual’s unique
22 needs related to mental health and substance abuse outside of an inpatient setting, but if
23 unaddressed could result in in-patient stay during crisis.

24 **Community Support Programs (CSP)** – programs for adults that are living with a serious mental
25 illness, minimal to intensive services, typically most significantly impaired individuals, often
26 through an involuntary Chapter 51 commitment (court ordered)

27 WHEREAS, while the State of Wisconsin elected to fully fund CCS programs in 2013 which greatly
28 expanded access and use of the program, CSP is not fully funded and whose clients typically represent
29 the highest costs and liabilities for Counties; and,

30 WHEREAS, Sawyer County consistently has a disproportionately higher number of CSP clients and has
31 incurred high cost in-patient placements which causes ongoing budget difficulties; and,

32 WHEREAS, if the CRS and CSP programs were to be similarly structured to the CCS program whereby the
33 State funds the non-federal share, counties would be able add and expand CSP services and have more
34 control over their budgets; and,

35 WHEREAS, a change to the CRS and CSP programs would aid counties with additional funds and tools in
36 responding to mental health and substance abuse crisis needs.

37 **NOW, THEREFORE BE IT RESOLVED**, that the Sawyer County Board of Supervisors does hereby request
38 that the Legislature and Wisconsin DHS restructure the Community Recovery Services (CRS) and
39 Community Support Programs (CSP) similarly to Comprehensive Community Services (CCS), and fund the
40 non-federal share of the costs of these programs.

41 **BE IT FURTHER RESOLVED**, that a copy of this resolution be transmitted to the Wisconsin Counties
42 Association (WCA), Wisconsin County Human Service Association (WCHSA), and Sawyer County's State
43 Legislators.
