4 **RESOLUTION 2023 - 25**

5 **RESOLUTION AUTHORIZING SAWYER COUNTY DOT GRANT APPLICATION**

6 **WHEREAS**, Section 85.21 of the Wisconsin Statutes authorizes the Wisconsin Department of  
7 Transportation to make grants to the counties of Wisconsin for the purpose of assisting them in  
8 providing specialized transportation services to the elderly and disabled; and

9  
10 **WHEREAS**, each grant must be matched and with a local share of not less than 20 percent of each  
11 county's allocation; and

12  
13 **WHEREAS**, Sawyer County's allocation of state aids for 2024 is \$79,889, thus requiring a  
14 minimum local share of at least \$15,978; and

15  
16 **WHEREAS**, Sawyer County believes the provision of specialized transportation services would  
17 improve and promote the maintenance of human dignity and self-sufficiency of the elderly and  
18 disabled.

20 **NOW THEREFORE BE IT RESOLVED**, by the Sawyer County Board of Supervisors, in legal  
21 session assembled, that the Board authorize Sawyer County to prepare and submit to the Wisconsin  
22 Department of Transportation an application for assistance during 2024 under Section 85.21 of the  
23 Wisconsin Statutes, in conformance with the requirements issued by the Department and also  
24 authorize the obligation of at least \$15,978 in county funds in order to provide the required local  
25 match; and

27 **BE IT FURTHER RESOLVED**, that the Sawyer County Board of Supervisors authorizes the  
28 County Administrator to execute a state aid contract with the Wisconsin Department of  
29 Transportation under Section 85.21 of the Wisconsin Statutes on behalf of Sawyer County effective  
30 January 1, 2024.
