1 Resolution 2024-22 2 **AUTHORIZING CITATION AUTHORITY FOR SAWYER COUNTY HEALTH & HUMAN SERVICES AND APPROVING** 3 AMENDMENT TO COUNTY ORDINANCES 4 RESOLUTION TO AUTHORIZE SAWYER COUNTY HEALTH OFFICER OR ITS DESIGNEE TO ISSUE CITATIONS 5 PURSUANT TO SAWYER COUNTY ORDINANCE CHAPTER 1, ARTICLE II AND AMENDMENTS OF SAWYER COUNTY 6 ORDINANCE CHAPTER 1, ARTICLE 2. 7 WHEREAS, the purpose is to achieve greater efficiency and economy in enforcing certain Sawyer County 8 ("County") Ordinances and to guarantee the fairness and consistency of enforcement procedures. 9 WHEREAS, pursuant to the authority granted by the Wisconsin Statutes, including but not limited to Wis. Stat. 10 Chs. 59 and 66, the County elects to use the citation method to enforce certain County Ordinances, including those for which a statutory counterpart exists. 11 12 WHEREAS, the County Health Officer or its designees shall enforce the provisions of Sawyer County Ordinances 13 Chapter 14, Article II Human Health Hazards, pursuant to the authority granted by Wis. Stats. Chs. 251 and 254 14 as administered by the County Health and Human Services. 15 WHEREAS, the County Health Officer or its designees shall enforce the provisions of Sawyer County Ordinances 16 Chapter 14, Article III Licenses and Permits Regarding Agent Status, and pursuant to the authority granted by 17 Wis. Stats. Ch. 97 and Wis. Admin. Code Chs. ATCP 72, 73, 75, 75A, 76, 78, 79 as administered by the County 18 Health and Human Services Department. 19 WHEREAS, the County wishes to amend the County Ordinances to specifically acknowledge that the County 20 Health Officer or its designees has authority to shall and enforce any Chapter 14 provisions of the County 21 Ordinances, as may be amended, thereby bringing the County Ordinances into alignment with the authority 22 granted to the County Health Officer and its designees in the Wisconsin Statutes. 23 WHEREAS, the amendment to the County Ordinances ("Amendment"), a copy of which is attached hereto and incorporated herein as Exhibit A, was discussed at the County Health and Human Services Committee at its 24 25 meeting on June 11, 2024, and the County Health and Human Services Committee voted to approve 26 (recommend approval, recommend approval in part, or deny) of the Amendment to the County Board of 27 Supervisors. 28 29 NOW, THEREFORE, BE IT RESOLVED, the county board of supervisors of the county of Sawyer does 30 ordain as follows: 31 32 1. Approval of Amendment to County Ordinances. The Sawyer County Board of Supervisors hereby 33 approves (approves and adopts OR denies approval of) the Amendment to the County Ordinances 34 attached hereto as Exhibit A. 35 36 2. Health, Welfare and Safety. The Sawyer County Board of Supervisors finds that the County's 37 action relating to the Amendment is beneficial to the health, welfare, safety and other interests 38 of Sawyer County's residents, taxpayers and visitors. 39

- (6) Sawyer County Shoreland-Wetland Protection Ordinance (Appendix B).
- (7) Sawyer County Peace and Good Order Ordinance (Section 16-1-1).
- (8) Sawyer County Animal Control Ordinance (Chapter 4).
- (9) Sawyer County Synthetic Drug Establishments Ordinance (Chapter 8, Article II).
- (10) Sawyer County Health and Sanitation Ordinance (Chapter 14).

Sec. 1-2-4 of the County Ordinances shall be amended to read as follows (added text noted in underscore):

Sec. 1-2-4 Authorized person to issue citations.

The following persons may issue citations authorized under this article:

- (1) Any County law enforcement officer.
- (2) Any designated employee of the County Zoning and Conservation Department.
- (3) Any designated employee of the Land Records Department.
- (4) The County Health Officer, or any employee of the County Health and Human Services Department designed by the County Health Officer.
