IN SUPPORT OF ASSEMBLY BILL FOR NORTHERN SKY THEATER PROPERTY TAX EXEMPTION

TO THE DOOR COUNTY BOARD OF SUPERVISORS:

WHEREAS, Under current law, property owned by a nonprofit organization that operates a theater is exempt from general property taxes if the property includes one or more buildings that are listed on the National Register of Historic Places and one or more theaters that have a total seating capacity of at least 800 persons (Wis. Stats. § 70.11 (29m)); and

WHEREAS, The attached Assembly Bill proposes to create an additional general property tax exemption for property owned by a nonprofit organization that operates a theater if the organization's federal income tax-exempt status is confirmed by a determination letter issued by the Internal Revenue Service no later than October 1, 1990 and the property includes one or more theaters that have a total seating capacity of at least 240 persons; and

WHEREAS, Northern Sky Theatre has requested that the County of Door go on record in support of the attached Assembly Bill which amends Wis. Stats. § 70.11 (29m).

NOW, THEREFORE, BE IT RESOLVED, That the Door County Board of Supervisors supports the attached Assembly Bill to amend the current law as described in the bill.

BE IT FURTHER RESOLVED, That a copy of this resolution be forwarded to Governor Evers, Senator André Jacque, Assembly Representative Joel Kitchens, and the Wisconsin Counties Association for their immediate attention.
